TEMPORARY MEMBERSHIP RULES 2011

Any non-member wishing to sail a mono-hull dinghy which is not owned by a club member and berthed at the club site including helming in club races must become a temporary member. Temporary members may join in club social activities current to their membership but will need to buy tickets where appropriate.

Temporary membership can be arranged by application to any committee member and on payment of the appropriate fee and completing full details on the temporary membership form but the committee member is not obliged to grant temporary membership.

Fees cover one boat two adults and up to four related children under 18. The same person (or group) may not be a temporary member for more than three separate days or two weeks in any one season.

Charges for temporary membership will be £75 per week reduced to £50 if the visitor can show they are a member of a club affiliated to the RYA. Daily rates shall be £15 and £10 on a similar basis.

Temporary members of one week or more will be permitted to hold a club access card subject to a deposit of £100 obtainable from the club secretary. Temporary members of less than one week will not be entitled to a club access card and will need to access the club during club events when the dinghy park and club facilities are open. The club card will open the electronic locks at the entrance barrier, the toilets/showers and the club room during normal club operating hours 9am to 8pm April to September (for other times please enquire).

The club welcomes temporary members under the following conditions:-

1. Temporary members may join club races (but are not eligible for points or trophies) and may use the club facilities during their period of membership.
2. Temporary members may **not** borrow club boats or helm rescue boats or the committee boat.
3. Temporary members qualifying to hold a club card must pay a deposit of £100. They may only hold the club card for the duration of their temporary membership and must return the card to the club Hon Secretary within fourteen days of the end of their temporary membership either by post or by other arrangement approved by the club Hon Secretary.
4. The deposit will be held against return of the card or other damage to club premises or property or the property of members of the club but the liability for damage will not be limited to the sum of the deposit. The charge for loss of a club card is £10.
5. Temporary members must keep all of the premises and the entrance gate locked unless they or other members are using them. The club must be left locked when you are on the water. Temporary members should be aware that the club locks operate automatically at the times published adjacent to the club room entrance and the club card will not operate locks outside of these times. IF IN DOUBT LOCK IT - all members have their own card.
6. Temporary members must abide by these rules and the rules of the club as described in the club handbook (White Book) displayed in the club house.

7. Temporary members must ensure that boats used by temporary members carry adequate third party insurance including a minimum of £500,000 cover in respect of third party risks, that they are sound and that their buoyancy arrangements are intact. Boats must carry adequate buoyancy aids.
8. The club will not accept any liability for damage or loss of property belonging to temporary members and the club will not accept any liability for personal injury whether or not attributable to or occasioned by the neglect, default or negligence of any of the officers, committee, servants of the club or members of the club.
9. All sailing dinghies must be berthed only on the berths allocated to them. No other type of boat or craft shall be allowed on the berths or the Club site road trailers may be stored in the trailer park but must not remain in the dinghy park. On arrival boats should be parked on the lawn area adjacent to the club until a berth has been allocated.
10. To avoid inconvenience to others at and around the launching slips, members must return their trolleys to their berths immediately after launching their boats.
11. Temporary members and Parents or Guardians are warned that the Club is only able to provide safety boat support during Club racing and Club training events and this applies only to crews engaged in racing or training. Parents and guardians have sole responsibility for their children and wards and must accept that the Club cannot exercise supervision or control. Children under the age of 12 years shall at all times wear adequate personal buoyancy whilst on the Club site. (Club Rule 24).
12. The safety of a boat and her entire management, including insurance, shall be the sole responsibility of the owner / competitor racing the boat who must ensure that the boat and crew are adequate to face the conditions that may arise in the course of a race. Neither the establishment of sailing instructions, nor the inspection of the boat under these conditions in any way limits or reduces the absolute responsibility of the owner / competitor for his crew, his boat and the management thereof. The race organisers shall not be responsible for any loss, damage, death or personal injury howsoever caused to the owner / competitor, his skipper or crew, as a result of their taking part in races. Moreover every owner / competitor warrants the suitability of his boat for the race or races. (Sailing Instruction 2).
